**WYOMING PUBLIC SAFETY PLAN -Infrastructure Support
for Statewide Juvenile Detention Centers**

The State of Wyoming will use a portion of its State Fiscal Stabilization Fund Government Services award to implement the Wyoming Public Safety Plan Infrastructure Support for Statewide Juvenile Detention Centers. The plan has been designed to accommodate Wyoming's rural setting, transportation distances to juvenile detention facilities, bed day usage rates, and cost of construction as well as the number of persons to be employed during the construction phase and the number of full time personnel to operate the facilities.

The infrastructure support funding, as revised, will provide for the building of 2 new juvenile hardware secure detention facilities in Casper and Cheyenne. The Casper facility will also include the addition of a staff secure youth crisis center. Additional staff secure bed facilities will be added in Basin, Jackson, and Sheridan.

The combined estimated total cost of these infrastructure additions is \$19,900,000. The total State Fiscal Stabilization Government Services Funds to be used for the addition of infrastructure is \$13,600,000. The estimated break down per project is as follows:

Casper -Building a new secure juvenile detention facility and staff secure youth crisis center.

- Estimated total cost of the facility is \$11,400,000
- Estimated State Fiscal Stabilization Funds allocated to the project are \$8,000,000

Cheyenne - Building a new secure juvenile detention facility.

- Estimated cost of the facility is \$7,500,000
- Estimated State Fiscal Stabilization Funds allocated to the project are \$4,600,000

Basin -Acquiring four staff secure detention beds.

- Estimated cost to secure the beds is \$350,000
- Estimated State Fiscal Stabilization Funds allocated to the project are \$350,000

Jackson -Acquiring four staff secure detention beds.

- Estimated cost to secure the beds is \$400,000
- Estimated State Fiscal Stabilization Funds allocated to the project are \$400,000

Sheridan -Acquiring four staff secure detention beds.

- Estimated cost to secure the beds is \$250,000
- Estimated State Fiscal Stabilization Funds allocated to the project are \$250,000
