White Paper – ARRA 09 Army Guard Operations and Maintenance

This paper provides information about Army National Guard (ARNG) Operation and Maintenance (O&M) funding as it relates to the American Recovery and Reinvestment Act of 2009 (ARRA), the State of Wyoming, the Wyoming National Guard and specifically the Wyoming Army National Guard (WY ARNG).

ARNG O&M funds under this Act are designated to improve, repair and modernize Department of Defense (DOD) facilities, restore and modernize real property to include barracks and invest in the energy efficiency of DOD facilities. These are federal funds allocated to the Department of Defense (DOD). The National Guard Bureau (NGB) through the Director of the ARNG (DARNG) manages the funds for DOD and executes the funds through the office of the United States Property and Fiscal Officer (USPFO) of each of the respective states, territories and the District of Columbia.

The ARRA includes \$266,304,000 for ARNG O&M projects. These funds will remain available until September 30, 2010. The WY ARNG has received \$5,593,000 of these funds to complete the following projects:

Using both federal and state contracting through the Wyoming Military Department and USPFO for Wyoming respectively, the WY ARNG has awarded contracts for all of these projects. \$4,627,311 was awarded through state contracting and \$965,689 was awarded using federal contracting for a total of \$5,593,000.
